- Definition: Alcohol abuse mortality is the rate of death due to the direct effects of acute intoxication or withdrawl from alcohol per 100,000 population. The definition includes ICD10 mortality codes F10 and X45. This definition excludes unitentional injuries (vehicle accidents, drownings, and other injuries) where alcohol use was a contributing factor in the death
- Objectives: Reduce the overall alcohol abuse death rate to 15.3 deaths per 100,000 population. *Healthy Alaskans 2020, Goal LHI-14*


Summary:

- Alcohol abuse is the seventh leading cause of death among Alaska Native people, at a rate of 29.8 per 100,000 in 2012-2015.
- Alcohol abuse mortality rates among Alaska Native people have not changed significantly between 1980 and 2015, however they have decreased significantly from their highs in the 2000-2007 time periods (p<0.01). During the same time period, alcohol abuse mortality rates decreased significantly among the non-native population, with a significant disparity between Alaska Native and non-Native mortality rates after 1996 (p<0.01).
- Alcohol abuse mortality rates among Alaska Native people varied from 96.4 per 100,000 in the Arctic Slope region to 17.7 per 100,000 in the Yukon-Kuskokwim region.




